Project summary	The Harry Ransom Center proposes a seven-month pilot project to outsource the digitization of 75 cassette audiotape interviews recorded by Mel Gussow (1933-2005), renowned New York Times American and British theater critic. Gussow was among the first to legitimize the off-off-Broadway movement and bring broad attention via the Times to early productions at LaMaMa, the Caffe Cino, and the Living Theatre—discovering writers such as Lanford Wilson and Sam Shepard, and actors Kevin Kline, Meryl Street, and Sigourney Weaver. Gussow also authored and edited nine books, including a biography of playwright Edward Albee and four on his conversations with playwrights Samuel Beckett, Arthur Miller, Harold Pinter, and Tom Stoppard. The digitized interview recordings, made available to the public via the Center's digital collections portal, CONTENTdm, will allow a multi-disciplinary research and teaching community to hear candidly from a range of figures representing forty years of American and British theater.

Description

For over 40 years Mel Gussow was the lead cultural critic for the New York Times. During the full length of his career, Gussow recorded interviews with stars and unknowns of the American and British theater. These interviews, recorded primarily on reel-to-reel and audiocassette tapes, were conducted at various venues largely in and around New York. Some of the interviews served as the basis of publications documenting the careers and processes of noted writers such as Samuel Beckett, Arthur Miller, and Tom Stoppard.

Mel Gussow died in 2005. His widow Ann Gussow placed the archive at the Harry Ransom Center in 2009. The manuscript portion of the collection was fully cataloged and an online finding aid published in 2010 when the collection opened to the public for research. Access to this collection is on-site, and limited research facsimiles of manuscript materials are created for a fee for patrons unable to visit in person. At the time of the collection's arrival, the audio recordings were physically separated from the manuscripts. The 977 recordings (1974-2004) comprise 921 cassettes, 55 open-reel tapes, and 1 compact disc. In 2010, the recordings were individually cataloged and rehoused if necessary. Patrons have access to only the 32 recordings that the Center digitized in-house for user requests; original recordings are not available for consultation.

### Condition

### Condition

Long-term preservation of all materials in its care is central to the Ransom Center's mission. The Center's Preservation and Conservation Division has six conservators and three preservation technicians on staff who provide expertise on preventive measures for and treatment of the Center's collections. The Center employs a Born Digital Archivist who also oversees the archiving of digital objects created in the Center's Digital Collections and Audiovisual Services operations.

To begin to address the preservation needs of recorded sound holdings, in 2015-16 the Center received a grant from the National Endowment for the Humanities to fund a preservation survey of 7,568 non-commercial recordings. For the survey, Center staff adapted the Preservation Self-Assessment Program (PSAP) developed by the University of Illinois, Urbana-Champaign. Based on visual assessment, a numerical condition score was calculated for each item, dividing the recordings into three categories: POOR (PSAP 1-59), FAIR (PSAP 60-79), and GOOD (PSAP 80-100). The results for the Gussow recordings are: 43 open-reel tapes in FAIR condition; 40 cassette tapes in POOR condition; and 862 cassette tapes in FAIR condition. The 32 tapes that had been digitized were not assessed.

The inherent vice of magnetic media leads to known and certain degradation. The most frequently observed issues affecting these tapes are related to the cassette shell and tape pack (popped strands, windowing, uneven wind). Without playing magnetic media, it is difficult to know the full extent of deterioration; NEDCC's evaluation of the tapes, however, reveals that the Gussow cassettes are in good condition for capturing their content with fidelity and accuracy. NEDCC recommends their digitization in advance of further deterioration. The assessment included ranking collections' research value into one of five categories: Unique, High, Pertinent, Limited, and None. Curators and collection management staff ranked the Gussow recordings in the HIGH research value category.

Scholarly Value and Significance

As the lead cultural critic at the New York Times, Mel Gussow was among the first to legitimize the off-off-Broadway movement and bring the attention of the Times to early productions at LaMaMa, the Caffe Cino, and the Living Theatre —discovering writers such as Lanford Wilson and Sam Shepard, and actors Kevin Kline, Meryl Streep, and Sigourney Weaver. The vast majority of his 977 interview recordings have never been included in publications and have never been heard beyond Gussow and his assistants. This remarkable collection captures a broad range of forty years of American and British theater through the voices of the people who made it, including not only those just mentioned, but also the likes of Katherine Hepburn, Laurence Olivier, Woody Allen, artist Al Hirschfeld, Public Theatre founder Joseph Papp, and playwrights David Mamet, Edward Albee, and David Hare, to name a few. The breadth of Gussow's interviews, correspondence, and criticism has made his archive a frequently consulted one at the Ransom Center.

It is rare to have such an extensive and diverse collection of interviews, made all the richer by having an interviewer like Gussow who understood the deep context of an individual's career and the theater at large. He knew which questions to ask to generate reflection and commentary. The digitized recordings, made available to the public via the Center's digital collections portal, will allow a multi-disciplinary research and teaching community (e.g. theater and performing arts, history, radio-television-film, creative writing, journalism) to hear candidly from figures (many of whom have since passed away) in their own voices. Theater artists working on productions of the many notable playwrights will find that these recordings offer crucial insights into the background and development of a play.

**Risk statement** 

In 2012, the Library of Congress stated in its National Recording Preservation Plan: "any analog audio recordings must be digitized within the next 15 to 20 years—before sound carrier degradation and the challenges of acquiring and maintaining playback equipment make the success of these efforts too expensive or unattainable." In the case of some media (e.g. lacquer disks and Digital Audio Tape), experts predict an even shorter timeframe.

Given these estimates, the Center has one decade in which to reformat priority audio collections. The sheer volume of recordings in the Center's holding suggests dual workflows (in-house, outsourced) and funding approaches (internal, external). Due to economies of scale, inadequate staffing for audiovisual reformatting, and costs associated with undertaking high-quality transfer of problematic media, the Center projects that 85-90% of the workflow must be outsourced. This proposed project allows us the opportunity to pilot outsourcing the digitization of unique, high value collection holdings. Indeed, this pilot will give us the experience we need to seek funding in the coming year to continue to digitize the Gussow recording sound holdings.

NEDCC's "high-touch, high-quality" approach is appropriate for these unique recordings. Gussow frequently interviewed "in the field"—in noisy restaurants, for example. Hence, these recordings require the best available technology and expertise if we are to achieve optimal results for aural comprehension. NEDCC's "traditional, specialized workflow" based on a "conservation ethos" (100% attended transfers and 100% quality control) affords this project the attention it warrants to achieve the best outcomes.

Rights, Ethics, and Re-Use The Center acquired the Mel Gussow collection in 2009. Gussow's widow, Ann Gussow, assigned copyright of the collection to the Center (see attached Deed of Gift). The copyright status of interviews and oral histories, however, is complex and multi-leveled. Peter Hirtle, copyright and cultural heritage materials scholar, argues that in cases where the most important part of the interview is from the interviewee, s/he serves as the author and copyright holder. In cases where the interviewer and interviewee equally contribute ("joint works"), copyright is shared by both parties. Unpublished interviews are protected by copyright for 70 years after the death of the interviewee; unpublished recordings made since 1972 (all of the Gussow recordings) are protected by copyright for 70 years after the death of the author. Mel Gussow died in 2005. To protect the rights of potential copyright holders, the 75 Gussow recordings will be made available for listening purposes only, via CONTENTdm, the Center's portal for digital collections

o The Center participates in a grant awarded to the Texas Digital Library (TDL) to create a Texas-based metadata aggregation hub for making collection metadata available via the Digital Public Library of America (DPLA). At the conclusion of the two-year grant (2016-18), the Center anticipates leveraging the aggregation services of TDL so that the Gussow collection metadata is discoverable via DPLA.

Seventy-five preservation masters in Broadcast Wave Format (24bit PCM, 2 track stereo, 96000Hz sample rate) and their corresponding access derivative MP3s (16 bit compressed, 320kbps, 44000 Hz sample rate) embedded with structured descriptive metadata and archived at the Texas Advanced Computing Center (TACC) at the University of Texas at Austin.



### SECTION 6: PROJECT PLAN July 1, 2017 – January 31, 2018

The Mel Gussow Sound Recordings collection project will include contributions from eight permanent Ransom Center staff:

- Dr. Ellen Cunningham-Kruppa, Associate Director for Preservation and Conservation, will act as Principal Investigator and will be responsible for the overall management and completion of the project, including liaison functions with NEDCC, ensuring financial compliance, publicizing the project and new resource, and compiling information for reporting to CLIR;
- Holger Waschinski, Radio, Television and Film Specialist, will serve as technical advisor. He will inventory the cassettes and digital files received from NEDCC, and copy master and access files to a local server in preparation for quality control.
- Doug Newell, Audiovisual Technician, will conduct quality control of the digital files and transfer master and access copies to archival storage in the Texas Advanced Computer Center (TACC) at the University of Texas at Austin;
- Elizabeth Gushee, Head, Digital Collection Services, will oversee and ensure that project goals and deliverables are met with regard to Dublin Core metadata, rights, and the creation of the Mel Gussow Sound Recordings collection in CONTENTdm.
- Lauren Walker, Digital Project Librarian, will photograph cassette labels, create metadata records, assemble digital objects; create the Mel Gussow Sound Recordings collection in CONTENTdm; and assist with writing the technical component of select publicity pieces.
- Amy Armstrong, Head, Archives Cataloging, will coordinate with the Head of Digital Collection Services to provide quality control for the metadata and CONTENTdm products created by the Digital Project Librarian;
- Abby Adams, Born Digital Archivist, will supervise the Audiovisual Technician in the transfer of the Gussow digital master and access copies to TACC.
- Dr. Eric Colleary, Cline Curator of Theater and Performing Arts, will approve the final descriptive metadata and collaborate with the Principal Investigator on publicizing the new digital resource.

Dublin Core will be used as the metadata schema, following the content standards outlined in DACS. Staff will repurpose item-level canonical metadata from the Center's internal Sound Recordings Database. Metadata fields for CONTENTdm will include: title, creator, date, description, subject, language, format, extent, duration, digital object type, physical collection, collection area, digital collection, repository, rights, call number, series, identifier, file name, and a link to the finding aid. Item-level metadata will be copied into Microsoft Excel and imported into CONTENTdm. Images of cassettes and audio files will be matched with the item-level metadata in the spreadsheet, directories will be created in the "ToIngest" directory.

Build Mel Gussow Sound Recordings Collection in CONTENTdm

Once the Excel metadata spreadsheets are complete and ingest directories built, Walker will create the Mel Gussow Sounds Recordings collection in CONTENTdm. High-level steps include the creation of a Dublin Core metadata template matching that of the Excel metadata spreadsheet and the addition of new terms to CONTENTdm's internally managed controlled vocabulary. Ingest is next, following the workflow for compound objects. A landing page will be created for the archive, including representative images and a description of the digital collection. The search interface for the collection will be configured to include search facets for creator, format, date, and identifier.

Assign CC0 (Creative Commons "no copyright reserved") license for the Gussow Sound Recordings collection in metadata, which will be freely available to anyone for any use. The XML files will be made available to users from the Mel Gussow Sound Recordings landing page in CONTENTdm as downloadable Zip files.

### **SECTION 6: DIGITAL PRESERVATION PLAN**

The Ransom Center is committed to the long-term maintenance of its digital collections. The Center's strategic plan emphasizes its priorities for developing its digital collections, maximizing access, and supporting scholarship and learning in the coming years. Among the key priorities being implemented is the further development and strengthening of a preservation plan for all digital collection materials.

Digital Collection Services and Technology Services staff of the Ransom Center transfer, reformat, and digitize collection materials in the Center's Digitization Lab (paper, books, photographs) and Audio Visual Lab (moving images and sound recordings); create policies and workflows that support the long-term stewardship of the Center's digital assets, including the development of digital preservation infrastructure; and oversee file management and storage of digital derivatives. Tasks and workflows are constantly monitored and reviewed by project managers. Documentation is recorded and maintained internally in departmental wikis on University of Texas at Austin servers. Training opportunities are provided to staff to ensure they are informed about the latest developments in digital preservation. Collaborations with other institutions on campus are numerous, and Ransom Center staff shares their experience with the professional library and archives community at large.

The University's Academic Technology Support (ATS) department provides administration services for the Center, including server and storage management services. ATS server support and data center personnel are required to adhere to strict standards established by the University that support system reliability and data integrity. The University's Information Security Office ensures the security of the systems and safeguards the confidentiality and integrity of digital data.

Master copies of the Center's digitized and born digital collections are stored at the Texas Advanced Computing Center (TACC) at the University of Texas at Austin on Corral, a collection of storage and data management resources. The data grid management software iRODS allows for storing data in a unified namespace using multiple storage resources, for replication of data so that copies exist on multiple systems, and for storage of checksums and arbitrary metadata within a file. Data in Corral is replicated off-site by a redundant node at the University of Texas campus in Arlington, with periodic integrity validation based on SHA256 checksums generated on upload. Replication in this context means that data is synchronously stored in both the TACC and Arlington storage installations, resulting in two copies of all data and metadata. If corrupt or missing files are discovered during integrity validation, the system will notify the Born Digital Archivist who will replace them with a replicated copy and delete the corrupt files. The Gussow recordings digital sound files will be uniquely named by a format/item-based naming convention and cataloged in the Center's local Sound Recordings Database. All canonical descriptive metadata is stored in this database, as well as documentation of the digitization process and information about the condition of the original item.

All files associated with the original physical item are stored in one folder, with preservation, production, and access copies in dedicated subfolders. MD5 checksum files are included within the subfolders. Digital derivatives and associated metadata, accessible through CONTENTdm, and web-based finding aids, are served separately from ATS server storage. ## About this collection

steel mill worker, an administrator for the New Deal program, an officer on the integrated ship SS Booker T. There are over 300 recordings in the Beecher collection, but of particular interest are field Alabama Democratic Primary.
